A 20' wide strip, the centerline described as follows:

Commencing at said POINT A thence North 44°42′51" East a distance of 70.71 feet to POINT B and the Point of Beginning of said strip; thence North 30°17′09" West a distance of 285.00 feet and said centerline there terminating.

Beginning at said POINT B thence South 29°42'51" West, a distance of 285.00 feet and said centerline there terminating.






## PARENT PARCEL DESCRIPTION:
